—	7-13-87	Annexing a certain tract of land, beginning on an old existing iron rod approximately three inches below the surface of the ground and 1.55 feet north-northwest from the base of a 12-inch pine, the northeast corner of Biscoe Christian Church Lot No. 38.
—	5-13-91	Annexing a certain tract of land, beginning with an existing ¾-inch iron pipe in the old line, the iron pipe being 50 feet north of the center line of the Highway N.C. 24/27.
